## Union Township Board of Supervisors Minutes/ Regular Meeting September 6, 2022

The regular monthly meeting of the Union Township Board of Supervisors was held on September 6, 2022. Supervisors Reitz, Allred and Bieber were present. Attendance sheet is also attached.

Meeting was called to order at 7:00 PM followed by the pledge to the flag.

Having reviewed the minutes of the previous meeting, a motion was made by Tom Reitz, seconded by Mark Bieber and carried to approve the minutes as presented.

Bruce Boynton, Planning Commission Chairman, attended the meeting along with Gene Kreamer of Kreamer Surveying, and members of the Russian Orthodox Church congregation to discuss the Land Development Plan for the church property located off of Felmey Road. The Board agreed that the Planning Commission should move forward with the Land Development Plan with the church being considered private, not commercial.

EMC, Gary Brouse attended the meeting to update the Board on an EOP Exercise that he will be hosting on November 16, 2022. The Fire Company, Emergency Responders and Board of Supervisors will be involved in the exercise.

The Roadmaster and Supervisor Bieber met with Charles Axtman, PE on several drain pipe issues. The Engineer will work on the plans for replacing the pipes.

The Central Keystone Council of Government sent a survey to Townships on the need for them to administer Sewage Enforcement with the upcoming retirement of Jim Sanders. The Board would like to have a fee schedule from the CKCOG and will be open to using them for enforcement based on that.

The Subdivision Ordinance was again discussed. All of the issues have been resolved with the exception of the language on mobile units, trailer/ RV parks and public grounds. Atty. Lyons and Supervisor Allred will discuss these issues further with Shawn McLaughlin.

Act 57 Tax Collection Law has been changed. The Township is required to do a Resolution or Ordinance to be in compliance with the new law. A motion was made by Billy Allred, seconded by Tom Reitz and carried to allow Atty. Lyons to prepare a Resolution to bring the Township into compliance.

Line striping quotes and roads to be line striped were reviewed.

The Railroad construction to replace the tracks on Rt. 15 including road closure was discussed.

Checks 5177-5202 were presented for payment with bills totaling \$35,097.14. A motion was made by Mark Bieber, seconded by Billy Allred and carried to approve bills as presented.

A motion was made by Tom Reitz, seconded by Billy Allred and carried to adjourn the meeting at 8:30 PM.
